The Healthcare Foundation raises funds in support of all those who live and work in our region, from Northern Santa Rosa to the Mendocino County border. We focus our investments in three areas: Healthcare Access, Mental Health, and Early Childhood Development. In 2019 we continued our support for the local health clinics, and continued to make major investments in mental health through Wildfire Mental Health Collaborative initiatives (SPR training, trauma-informed yoga, individual/group counseling, etc.). We also provided a second capacity-building grant for local early childhood development agencies. We continued to fund scholarships for nurse practitioners and mental health professionals who agree to stay in our area and serve in clinics, schools, and nonprofits to build a long-term pipeline of

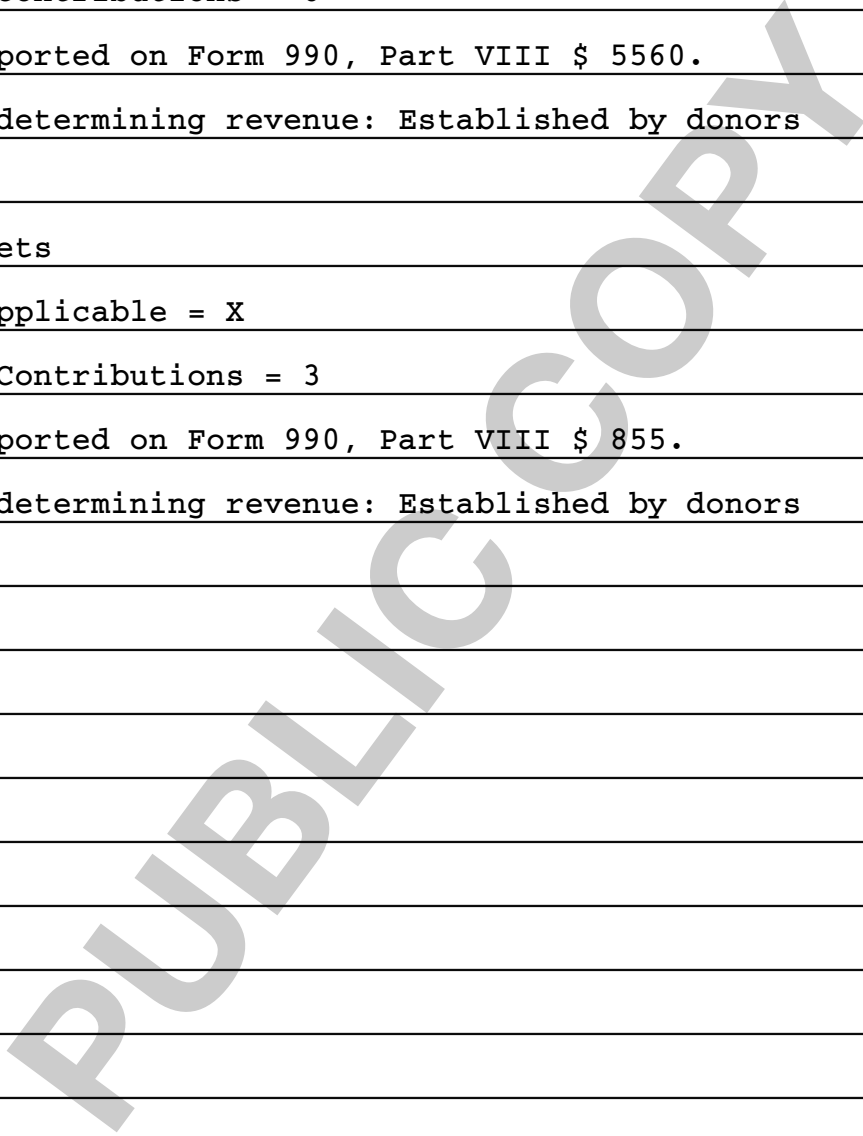

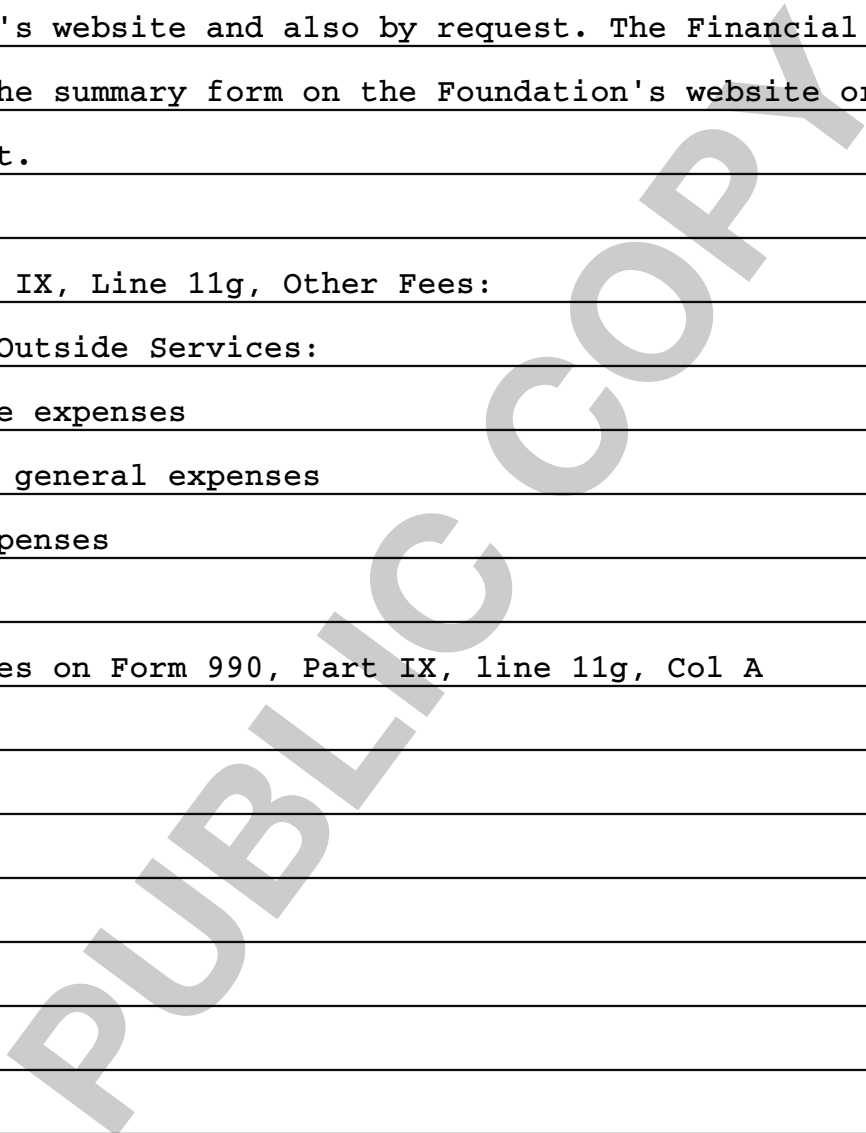
